#### OUR VISION

We believe that every child deserves a safe and permanent home and will, therefore, provide a trained CASA volunteer to every abused, abandoned, or neglected child who needs one, and advocate to improve the lives of children in the foster care system.



#### Dear Friends,

What began as a year that looked familiar, turned into a time of unforeseen crisis and challenges that caused all of us to reexamine our assumptions about the systems we have in place and how to support one another. We have all been reminded, in various ways, about the meaning of relationships and home.

For youth in the child welfare and juvenile justice systems, the sense of connection to others and to the larger community became that much more important but, at the same time, even further out of reach as systemic inequities were widened, access to services diminished and the ability to leave our homes for the supports provided by school and family visits slowed down or stopped entirely.

The willingness to commit oneself to the wellbeing of others and dedication to stability for all children have always defined the CASA experience, but perhaps no more so than when the world seemed to shut down in response to the introduction of COVID-19 and in the face of a racial reckoning. Our CASA program shifted gears and restructured our operations. This included staff working remotely and offering virtual training for our volunteers so that we could continue to prepare them to meet the needs of the youth we serve.

On the ground, our volunteers:

•Continued to connect with children and youth of all ages to combat isolation. They took advantage of virtual opportunities to take classes and tours. They read stories, played games and enjoyed meals together online. When circumstances allowed, they met for time outside and maybe some exercise.

•Helped children meet basic needs. Volunteers connected families with resources for food, sometimes delivering food to families who were unable to get to distribution sites.

•Distributed tools to tackle distance learning, giving out new laptops, printers and other school supplies that were donated by you or purchased with your generous donations.

•Provided personalized advocacy and support, attending court hearings, making sure birthdays were celebrated, assisting with schoolwork and collaborating virtually with teachers, lawyers social workers and other professionals.

During times of crisis, our community comes together, driven by compassion and a desire to collectively overcome challenges and support one another. With your generosity, our CASA program has remained focused on ensuring the children we serve have the deserved opportunities to thrive. We are grateful for your continued partnership that empowers us to make progress on our mission to provide each child in our juvenile court system with a caring, consistent adult. On behalf of the youth we support, thank you for your empathy and enabling us to offer hope and make a meaningful difference for children throughout our community.

# Why CASA Matters

A child in foster care needs someone to look up to, someone to count on. Having a stable relationship with a supportive adult can help children thrive, even when they have faced significant trauma and hardship.

In San Mateo County, CASA volunteers advocate one-on-one for the hundreds of children and youth who are in the child welfare and juvenile justice systems. Often from an early age, these children face unimaginable trauma and are forced to deal with complex emotions that should not be part of childhood: sadness, anger, fear, hopelessness, and grief. Their hearts ache. They bear the scars of trauma - inside and out.

All children have the right to live in an environment free from abuse and neglect. They need a family and a permanent place to call home. To thrive, they need consistency and connectedness in their lives. CASA volunteers are devoted to making those things possible for children in foster care and on probation. They visit weekly with their youth and maintain ongoing communication with all parties involved to best serve the youth's interests. They provide a voice for the child in court to ensure receipt of and continuity of services. For the volunteer, this means a minimum 18 month commitment, or until the case is closed, and an average of 11 hours per month of service.

# The Impact of COVID-19

The COVID-19 crisis has changed the world in ways beyond what we can imagine. It will have a lasting impact on our community, including the children we serve, our volunteers, and our staff at CASA of San Mateo County. In early spring, we closely monitored the situation both locally and nationally, remaining in close and regular communication with court and county officials. Throughout the many challenges and changes, our CASA volunteers have provided unwavering support for their youth.

CASA volunteers have been fierce education advocates for their children to reduce the potential for learning loss. They have responded to children in crisis and connected them with vital resources. They have connected older youth with food, housing and other resources to provide stability during a time of significant uncertainty. Importantly, when many things in the world came to a halt, CASA volunteers continued to provide regular reports and crucial information to our local child welfare and juvenile court judges to assist them as they made life-altering decisions impacting children and their futures.

# Racial Injustices

The late Supreme Court Justice Ruth Bader Ginsburg once said, "Real change, enduring change, happens one step at a time."

CASA exists because we recognize the importance of human connection and the power that connection has for every child, particularly those undergoing trauma. Time and time again, the presence of one consistent adult, a CASA volunteer, has provided our children with the strength and voice they need.

The heartbreaking murder of George Floyd underscored a history of violence, injustice, and pain around race and poverty in our country. Many were left questioning how to process, what to do to keep their spirit intact and how to respond meaningfully and in a way that moves us forward. If this is the impact on the adults around us, how must already-vulnerable young people be expected to respond? How can we continue to provide needed support and give them a community where they can all live with dignity, hope, and equal opportunity for success?

Our CASA youth may have more lived experience with these issues than some of us and, likely, more lived experience than we would want for any child.

Our program continues to explore and implement opportunities to provide our community with tools to help navigate these issues and support our CASA youth and volunteers. We will continue to provide education classes for our staff and volunteers and resources to always learn more. We are committed to taking the steps needed to provide knowledge and opportunity to contribute to diversity, equity, and inclusion and racial justice for all.

# Trauma and Resilience

## Children in foster care are most vulnerable to adverse childhood experiences

Pediatrician Dr. Nadine Burke Harris, California's Surgeon General, has dedicated much of her career to spreading the word about the dangers of toxic stress to children, championing a multidisciplinary approach to these problems to improve health and build resiliency in youth.

Childhood adversity not only affects brain development; it can alter children's hormonal systems, immune systems, and even their DNA. This can cause behavioral issues, learning difficulties, and physical health problems. Exposure to ACEs (Adverse Childhood Experiences) includes abuse, neglect, domestic violence, and parental mental illness and substance abuse. Children in foster care experience these traumas far more often than other children, and it can shape not only their behavior and health but also their worldview.

As powerful as ACEs can be in the lives of children, there are concrete solutions to reduce their impact. In a recent interview, Dr. Burke Harris explains that the "science and research show that having someone to look out for you is really important for improving outcomes. Biologically, safe and stable and nurturing relationships release a cascade of processes in the brain and the body to help arrest the biological stress response. That's the power of a program like CASA, that supports kids who are at known risk, who are going through out court system. CASAs provide someone who is just there for them, who is just looking out for them."
