More Details Emerge on California Relief Funds for Current, Former Foster Youth

California will issue \$600 prepaid cash cards to eligible current and former foster youth between the ages of 18 and 21, and \$1,500 cards to those between ages 22 and 26. The state projects that 31,000 people will be eligible for one of those payments.

Advocates Tout Data Showing Raise the Age Laws Haven't Overwhelmed States' Juvenile Facilities

Roughly 100,000 fewer youth will enter the adult criminal justice system this year and in future years, as a result of a quiet but powerful reform movement known as "Raise the Age."

According to a new national report, the reform allowed those tens of thousands of young people to avoid criminal records and serving time in notorious prisons.
