Meet Corrie Conrad, VP of Communities and Impact at Box, and Executive Director



**Senator Cortese and Chesa Boudin
"Common Sense" Basic Income
Measure for Foster Youth Moves in CA
Senate**

A state senate bill authored by Senator Dave Cortese (D-15) and backed by San Francisco District Attorney Chesa Boudin that would provide "Universal Basic Income for Transitional Age Foster Youth Act" is now being heard by the Senate Appropriations Committee. SB 739 would establish a pilot program to provide \$1,000 every month for the around 2,500 Transitional Age Youth (TAY) aging out of California Foster Youth programs.

**Study Finds Pervasive Racial Bias in
California's Child Welfare System**

A [new study](#) in the *American Journal of Public Health* examines the scope of racial inequities within the child welfare system that researchers have pointed out for decades by tracking the rates of child protective service involvement in the lives of the half a million children born in 1999 in California. CPS investigators often need to make quick, high-stakes decisions about whether a home is safe and suitable for children, and the broad nature of neglect leaves such decisions rife with implicit bias.
